Peoples Security Bank has renewed the CD. The new term will be 12 months.

JHA sent a Proposal for Professional Services.

PA Dept. of Community and Economic Development sent notification that the new UCC permit fee has been raised from \$4.00 to \$4.50.

PSATS sent a notice that Act 42 of 2017 authorizes the placement of 10 Category 4 casinos with the Commonwealth. It also grants municipalities the authority to prohibit these casinos within the boundaries of the

municipality. The municipality must pass a resolution and deliver it to PA Gaming Control Board by December 31, 2017.

SWN sent a Renewal Permit to Drill – Bolles SE 2H.
